SUBJECT: FY 2022-2024 Overall DBE Goal Acknowledgment Letter

Dear Mr. Omishakin:

This letter serves to acknowledge receipt of the California Department of Transportation (Caltrans) Federal Fiscal Years 2022-2024 Goal Methodology Proposal for its Disadvantaged Business Enterprise (DBE) overall goal. While the goal proposal is under review by the Federal Highway Administration (FHWA) for adequacy and soundness, Caltrans must operate under its proposed 22.2% DBE goal as of October 1, 2022, and until the FHWA California Division informs otherwise.

As of March 2010, the US Department of Transportation requires recipients of DOT financial assistance to submit an overall DBE goal methodology for approval by the appropriate DOT operating administration every three years. Over the next few months, the FHWA will review the goal methodology for consistency with the DOT DBE regulations at 49 CFR Part 26 and with the DOT DBE goal-setting guidance. The FHWA may then approve the submitted goal or, after consulting with the Caltrans, request an adjustment.
