1. FY23 FHWA & Caltrans Civil Rights Program Joint Risk Assessment: Threats & Opportunities

PURPOSE (Time to complete: 15 minutes)

Thank you for responding to our FY23 FHWA/Caltrans Civil Rights Program Risk Assessment. We appreciate that Caltrans employees were already asked to address risk within the DBE program; therefore, when responding to this assessment, consider the entire Civil Rights program plus the DBE program, Title VI, Americans with Disabilities, and Contractor Compliance, On-the-Job Training/Training Special Provisions, EEO, & OJT & DBE Supportive Services, LEP, EJ, LPAs. Provide us with your top "opportunities" and "threats" that might lead to improving collaboration among our agencies, partners, and stakeholders. The goal here is to improve the efficiency and effectiveness of our entire Civil Rights program and project outcomes within the context of the Federal-aid highway program.

DEFINING RISK

Risk is the effect of uncertainty on our agencies' objectives. It manifests as an "opportunity" (potential gain) or "threat" (potential loss). This assessment provides three instances to identify an opportunity and/or threats for up to six responses. Then identify the program/area of concern (interest) to give us context. We then ask you to identify a potential mitigation strategy. Lastly, we ask you to associate an opportunity or threat with a set of impact, likelihood, & scope criteria to help gauge the significance of the event if it occurred.

Likelihood Criteria

Unlikely: The event could possibly occur but is unlikely.

Possible: The event could occur under specific conditions and some of those conditions present.

Likely: The event is likely to occur in most circumstances.

Almost Certain: The event occur sin most circumstances or is happening now. Impact Criteria

Catastrophic: Large unacceptable financial loss, severe budget variance. Very significant harm to image with substantial impact on effectiveness. Large and unacceptable operational impact, long term business interruption. Qualified audit finding.

Major: Very significant financial loss, major budget variance. Major embarrassment leading to significant impact on effectiveness. Unacceptable operational impact, short term business interruption. Leads to material weakness.

Moderate: Significant financial loss and variance to budget. Moderate

embarrassment impacting short term effectiveness. Moderate operational impact, business not interrupted. Leads to Audit findings. Minor: Minor financial loss, small budget variance. Minor embarrassment, but no harm to image or reputation. Minor operational impact, business not interrupted. Leads to audit findings.

Insignificant: Minimal or no measurable operational impact. Can be managed with routine activities. Leads to immaterial audit findings.
