#### Build America, Buy America Background

- Original Buy America Requirements (23 CFR 635.410)
- Infrastructure Investment and Jobs Act November 15, 2021
- Office of Management and Budgets (OMB) Initial Guidance April 18, 2022
- Federal Highway Administration (FHWA) 1983 Manufactured Products Waiver
- U.S. Department of Transportation (USDOT) 180-Day Temporary Waiver May 19, 2022
- Build America, Buy America Implementation Date November 10, 2022
- USDOT Request for Information on Buy America for Construction Materials July 28, 2022

# **Build America, Buy America Implementation Efforts**

- Buy America Implementation Team (BAIT)
- Implementation date November 10, 2022
- Mandated for federal-aid risk projects
- Mandated for nonfederal-aid risk projects, but exception allowed with identified domestic supply concern
- Specification owners, authorized material lists, and department-furnished material contracts
- Standard Special Provision (SSP) 6-1.04, "Buy America" preview posted September 23, 2022

#### Build America, Buy America OMB Guidance – April 2022

- Three Areas of Buy America Coverage
  - Steel or Iron
  - Manufactured Products\*
  - Additional Construction Materials
    - (non-ferrous metals, plastic or polymer-based products, lumber, glass, and drywall)
- Any item can only be classified in a single area of coverage
- "Construction Material" vs. "Manufactured Product"
  - Combination of two or more construction materials in production results in a manufactured product.

#### **Build America**, Buy America Exclusions

- Tools and equipment\* used in constructing the work
- Temporary elements not incorporated into the permanent work
- Existing items relocated from one location to another on the project
- Raw materials, surface treatments, and coatings for <u>additional construction</u> <u>materials only</u>
- Manufactured products not containing steel or iron\*
- Other exclusions

- Reconsideration of 1983 FHWA Manufactured Product Waiver March 2023
- Future Reconsideration of Nondomestic Steel or Iron Raw Materials TBD?
- Contract's Original Buy America Requirements Throughout Contract's Duration
